Disclosure type	Definition	What it includes
Full	Complete and transparent information for a given ESG metric is provided.	All relevant data, context, and supporting evidence are shared. This typically means the company has mature ESG practices and robust data collection systems.
Partial	Some information is shared but doesn't meet all requirements	May include qualitative insights, early-stage data, or limited metrics. Often used when a company is still developing its ESG capabilities or lacks complete data.
Explanation	Instead of data, a rationale for why disclosure is not currently possible is provided.	A narrative or justification—such as lack of relevance, data unavailability, or ongoing development.
